#### Roumania-forexportonly

Welcome to my blog, which I wrote to help publicise my new book (my only book actually, but I thought it sounded better that way!). My name is Rolie, and I worked for the European Commission until I had my trouble which I am not ashamed of now because everybody know about it. I had problem with paranoia, I was seeing characters from comic books following me, and I had to ntake extended leave from the Commission to allow me to get back to normal, which I am now nearly.

I brought my expenses claims file with me from my job, and I was able to work out from that where I had been for several years before (or at least where I was supposed to have been, but let us not go there!). As part of my therapy I was encouraged to write down all the things from my past, and the result was a book that I call "For export only". I got the name from a bottle of beer that I was drinking one night, and I thought that it suited the thing I was trying to say, that adoption is not good and that children should not be adopted, especially not by foreigners in another country. It could be possible maybe that children could be raised in a culture that is not same as their own, or even worse, it is possible that the bloodline of Dutch and German people could be contaminated greatly by gypsy blood from Roumania. If the child was adopted by Dutch couple it is possible that nobody would know that they had gypsy blood, because the name of the child would then be same as the adopting couple. In future, it might be that maybe my child will marry such gypsy and not know that it is gypsy, therefore contaminate my family with gipsy blood. So altogether, we must work to keep these children in Roumania, in institutions if necessary, but never to be adopted outside of Roumania (possibly in Africa maybe, but they do not have money to raise their own children, never mind Roumanian children, so is not a problem right now).

I brought my book to publishers in Brussels, but they know nothing, they tell me it is not good enough for publishing. They are ignorant and stupid, especially the man in the big place near Parliament, you know who you are! Ignorant! I tried many places, but all are stupid or maybe the ignorant man has already contacted them all and told them not to publish my book. In any case they do not understamd how important is my book and how many milluions will buy it if it is published.

So, I made a new plan. I speak to my friend Rupert and get his advice. He already has a book that is published and maybe he knows some publishing company that is not stupid. he tell me that he has used "vanity publishing". I have not heard of such company, but he tells me no, it is not company, it is when person publish book themselves, ignorant people call it vanity because they do not understand. He made a nice book but was expensive to publish, but he show me how the charity he was working for paid for publishing, although they did not know it was his book, they think is just printing reports. Now he has a book, and he can sell it and make millions!

So, I asked him, how much money did you make from book? Nothing he said, nobody buy it except my family. Why is that? I ask him. Because they do not understamd, he says, but he is not worryed. he says that he bring book to peoples offices in Brussels when he has meetings, and give them present of book, and they think he is brilliant person for writing book. He give away many hundreds, nobody reads, but everybody think he is brilliant!

Very good idea, I think, I will make the book and find some money in European Commission to pay for print. But nobody will agree to pay. So I ask my therapist, and she say to go ahead and pay myself, is important to get the story off my chest. So that is how the book happened.

Not many people buy the book yet, just about 20 persons from internet and one goes into shop in Brusels where book is, but I know that when stupid people in newspapers make publicity for the book, many millions

#### will sell and I will be rich.

If you want a free copy of book, write to me at European Commission and I send you one, but only if you promise to read it! Also if you go to Commission offices there are many in boxes beside my desk and you can take on for free if you wish.

When will the interest of the child be finally at the centre? Not yet obviously, because the book of Roelie Post makes clear how easy this principle of the Convention on the Right of the Child is put aside. And replaced by the wishes of a few gay women at the heart of the European Commission and in Bucharest. With this the de-institutionalisation process in Romania was frustrated and again the power of the institutions was restored, creating career opportnities not only in Brusels buy\t in Romania aas well. Already many families were ready to take children out of the orphanages, where they often lived in diar circumstances, to take them into their family. But now we have stopped all this. And the story goes on, inthis is a long book to read unless you have lot of patience.
