"Pursuant to the directions in the judgment in W.A.No.191 of 2019 dated 1.2.2019, giving liberty to the appellants to make an application seeking relaxation of age criteria, application dated 15.3.2019 is stated to have been filed by the petitioners herein. Contending inter alia that the said application has not been disposed of and therefore there is wilful disobedience of the abovesaid judgment, instant Contempt petition is filed.

Mr.Jaishankar V.Nair, learned Central Government Counsel is directed to get instructions as to why the application submitted by the petitioners is still pending.

Post after two weeks."

Reverting, Mr. Jaishankar V.Nair, learned Central Government Standing Counsel submitted that representation received along with Contempt application would be placed before the Relaxation Committee and appropriate orders in accordance with law will be passed, within three weeks from the date of receipt of a copy of this judgment.
