DG EMPL ([REDACTED]) contacted me over the phone on this matter. I explained to her our position that [REDACTED]. 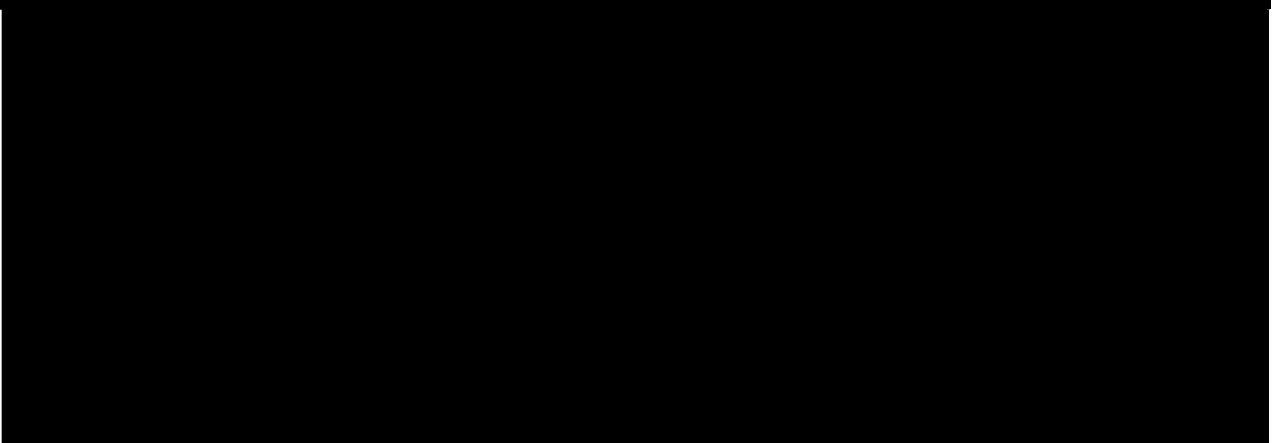
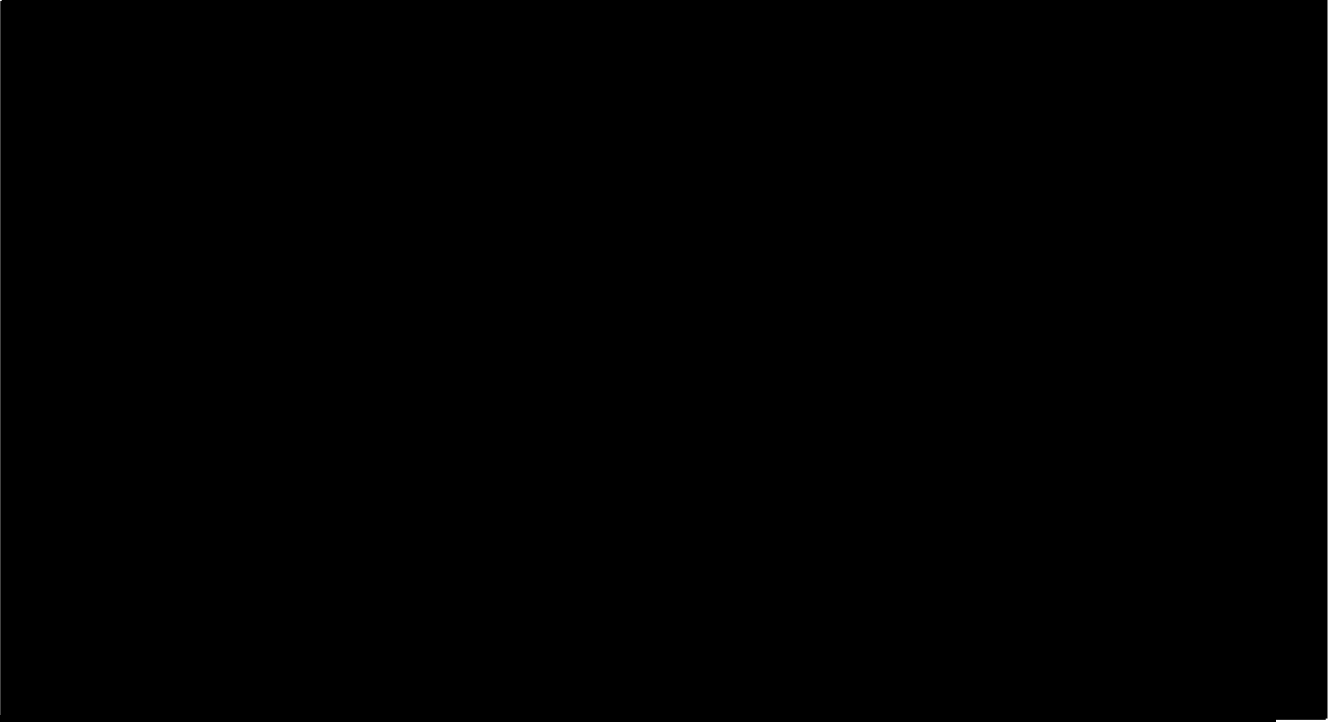
