Corruption, combated "frontally, honestly and directly" In parallel with the dissemination of incriminating press releases addressed to the opposition representatives, the Minister of Justice, Cristian Diaconescu, emphasized, during the videoconference with the prefects at the Victoria Palace, that "the problem of fighting corruption must be approached head-on, honestly and directly, so that it can be solved as soon as possible soon, considering that the signals coming from the citizens and those received from outside are somewhat consensual". the subject or an over-mediating of it, it is clear that there is a problem in Romanian society." Tariceanu, accused of Power Liberal Vice President Calin Popescu Tariceanu is increasing the ranks of those incriminated by the PSD: "We consider it necessary to remember the corruption scandals in which the media reported the involvement of the Citröen baron, Calin Popescu Tariceanu. The former Minister of Industries and Commerce succeeded the performance of linking its name to the more than dubious haste with which the state institutions began to purchase imported Citroen cars between 1997 and 2000. No less than 570 Citroën cars were bought with the money taxpayers, in a 6-month interval, by RomTelecom and SNP, companies that suddenly felt the need to enrich their fleet with cars worth over 19 million USD". "

The capture of Brasov by liberals" The PSD also draws attention to "the seizure of Brasov County by the liberal oligarchy. The PNL barons in the county, as the media has warned countless times, are luxuriating in huge villas, buying hectares of land in the hope of selling them at a higher price, allocating billions of lei from taxpayers' money for trips abroad, organizes auctions whose winners are close to the PNL or even avoids the auction procedure", according to another PSD press release. As an example, the case of the president of the Brasov County Council, "the baron of the local media, Aristotel Cancescu, who purchased, as reported by the press, the headquarters of the MIX trust at Uzina Tractorul, on the basis of the publicity given to it, spent approximately 2 billion lei for restoring the facade of the County Council building, although he knew that it belonged to the Ministry of Justice; created a special fund at his disposal from which he can distribute amounts as he wishes". In PSD's opinion, "another PNL baron of Brasov is the mayor loan Ghise, who in three years of office was out of the mayor's office no less than 200 days. Ioan Ghise is a special type of baron, which not every ordinary mortal can reach. Thus, in 2003, only one person managed to reach his audience. Regarding public money, the media noted how, two years ago, the Brasov City Council allocated one billion lei for the elaboration of a study on the decentralization of the heating system. Two companies participated in the auction, and the mayor sent an address to one to convince it to lower the offer by 100 million, in order to win the auction". it is shown in the PSD press release. The list of "Barons of Brasov" is expanded by Nicolae Vlad Popa, president of PNL Brasov. "He didn't miss the opportunity to sell the valuable period furniture from the party's headquarters, a fact that gave birth to a huge scandal in the liberal branch, reported by the press. Shortly after, he bought a Jeep Grand Cherokee", the Bureau mentions of the press of the PSD.**PNA - instrument of political struggle**PD considers the manner in which PSD understands to use the National Anticorruption Prosecutor's Office as an instrument of political and electoral struggle against its opponents to be unqualified. In a press release given yesterday to PD publicity, it shows that "PSD is distracting attention from the lacubov scandal, launching dirty attacks on some opposition leaders using PNA as a means of intimidating and discrediting them. The PSD attacks confirm the fact that PNA was created in this very purpose of harassing the members of the opposition, the institution being under the direct authority of the Government", it is mentioned in the document. The Democrats say that, "with regard to the accusations brought to the PD deputy, Radu Berceanu, we informed the PSD that in the period 19992000, when the SunOil file is under investigation, Radu Berceanu made himself available to the General Prosecutor's Office, on his own initiative.

Potrivit raportului, SC Diafarm SRL a intocmit 14 proiecte SAPARD, in valoare totala de 235.425 de euro, referitoare la drumurile din zonele rurale. Actionarul majoritar al SC Diafarm SRL este Rodica Dobrea-Climec (avand 92,42 la suta din actiuni), iar proiectele au fost verificate de sotul ei, Niculai Dobrea-Climec. Pentru verificarea proiectelor, Dobrea-Climec a fost platit cu 22.738 de euro. In celalalt caz. SC Sarom Impex SRL - al carei unic actionar este Violeta Veleanu - a intocmit trei proiecte SAPARD, in valoare totala de 70.738 de euro. Doua proiecte vizau canalizarea cu apa in zonele rurale, iar al treilea alimentarea cu apa in acelasi mediu. Cele trei proiecte au fost verificate de Radu Adrian Veleanu, care a primit 1.380 de euro pentru serviciile prestate.Corpul de Control al premierului a dispus ca aceste concluzii sa fie transmise Agentiei SAPARD si Consiliului Judetean Suceava, care ar urma sa ia masuri in acest caz. In plus, aceeasi institutie cere ca raportul intocmit sa fie analizat de Oficiul de Lupta Antifrauda al Comisiei Europene si Parchetul National Anticoruptie. Agentia SAPARD a decis sa reia licitatiile pentru desemnarea persoanelor care vor verifica toate cele 16 proiecte din judetul Suceava la care au fost depistate conflicte de interese. In judetul Suceava, 58 de consilii locale au depus cereri de finantare pentru proiecte de reabilitare a infrastructurii prin programul SAPARD, in valoare totala de 46,6 milioane de euro, din care pentru 37 au fost semnate deja contractele de finantare, iar pentru 24 a fost organizata licitatia pentru desemnarea constructorului.

Bilantul lui SapunaruDeputatul PNL de Vrancea, Nini Sapunaru, a realizat si el un bilant al "celor patru ani de coruptie si abuzuri in Vrancea". Sapunaru aminteste unele din evenimentele controversate, "cu iz de coruptie si abuz, petrecute in ultimii patru ani in judetul Vrancea". Libertatea presei in Vrancea este o gluma amara", arata Sapunaru in cadrul unui comunicat de presa. La acest caz adauga "cele mai mari tunuri care reprezinta afacerile pe bani publici". El face referire la "contracte de zeci si sute de miliarde au fost castigate in urma unor simulacre de licitatii de catre firma AISPA STAR, patronata de controversatul Cornel Prunache". Lista continua cu manevrele dubioase in folosul personal al PSD-ului local si cu faptul ca "in patru ani de conducere a judetului, PSD a

terorizat mediul de afaceri vrancean prin initierea programului de sponsorizari fortate". El spune ca "pentru ca oamenii de afaceri sa fie intimidati, contractele sunt inmanate de reprezentanti ai Directiei de Finante sau ai Garzii Financiare. Aceste contracte trebuie onorate obligatoriu".Sapunaru puncteaza si "incercarile de spoliere a agriculturii vrancene de catre prefectul George Baesu, care a cerut imperativ producatorilor de struguri vranceni sa-si vanda productia numai catre cumparatori din judet. Din intreaga afacere ar fi avut de castigat intreaga clientela politica a PSD Vrancea".
