It has come to our notice that [REDACTED] (10)(2e) tried to send two children, [REDACTED] (10)(2e) to the Netherlands .

These children were initially proposed via your organisation to Dutch adoptive parents.

[REDACTED] (10)(2e) was convicted for child trafficking earlier. I, alongwith [REDACTED] (10)(2e) have been the petitioner in many cases, including the ones for these two children, where we argued that the children had been trafficked and should not be sent abroad.

I have filed a petition in the High Court recently against an order by Justice [REDACTED] (10)(2e) allowing these children, after similar prolonged litigation in the higher courts, (High Court bench and Supreme Court) where this was not allowed. If you can give me the exact nature of your organisation's stand and history of these particular two children, I would be grateful. Kindly mail your letter to:

Yes I was already writing an e mail to (10)(2e) before you wrote this, that I would not do any research, that SA is not my contact that I did not even see the Evidence, that (10)(2e) had shared with with (10)(2e).

(remember I was on the phone)

But I stopped writing and did not send the E mail, because like this I do not win anything either.

And to be honest I do not even want to get into this, as long as (10)(2e) is there. For me it gets so complicated.....I do not know about SA .

Your last mail with the newspapers clippings about SA kept me awake a long time...I juts do not understand how this can be possible!

The earlier (10)(2e) (10)(2e) who is now only in project aid and left adoption, seemed to me as a person who would not do such a thing. I know her because she has come to the Netherlands quite a few times.

I was ony questioning her then if she does pro life counciling or if she gives the mothers also good information about abortion.

And she said she does, that if a mother decides for an abortion that she respects that. And I asked if she also directs woman to abortion posisibilities. She said if they want we do.....

But this was only a short talk . Her projectinvolvement with aids related children is excellent actually.

And the woman (10)(2e) that took the place in adoption matters I met, but never talked to her. Anyhow, (10)(2e) told me that relationship with SA really lost quite a bit of its trust since this was known about the drug addict thing.

A thing that puzzles me and I wanted to write you about already was:

The thing that was said to (10)(2e) that the man would be using drugs was only a said/spoken information, was not it? I do not recall an E mail of (10)(2e) about this fact? I thought (10)(2e) had spoken to her on the phone and then (10)(2e) might have mailed you.....

But in the newspaper is written that [REDACTED] (10)(2e) wrote an E mail, but I think she did not?? Then it fits if [REDACTED] (10)(2e) says she can not recall a mail about this?
I just do not remember....

Maybe it makes sense if the Joustra Commission investigates what dutch officials may have done wrong.

Personally I don't see much sense in the Joustra Commission investigating this.

All what needs to happen, is that the Minister acknowledges that this happened and request the Openbare Ministerie to open a broader criminal investigation extending to India and into the conduct of (10)(2e) and possible involvement of dutch officials.

As part of it the OM can request via letter rogatory assistance from the indian criminal investigation agency CBI.

The adoptive families, the adopted now adult children, can request their cases to be investigated by the OM.

The Indian criminal investigation agency CBI can then verify the documents and look into each case.

Additionally the Ministry can fund ACT / ARC and we can equally assist the families and adoptees with their searches and hopefully the reunions.

We are also in a position, to push the Indian government to set up a local DNA Database, so that even cases where the paperwork was totally concocted can be solved.

It's all not rocket science.

It's just obvious that since now almost 14 years the ministry of justice has no interest in the fact that any truth comes out. Just a total cover up.

For the rest of India, answers on whether the adoptions were conducted in line with the existing legal framework can only be found, if one is able to trace back the indian families.

You cannot even do it from the desk in the Netherlands.

The Wereldkinderen Partners are uncooperative. That is a big fight we fight since many years.

Though we solved some Dutch cases, and can provide you detailed case studies on request.

First and foremost ACT needs funding to be able to fight it through in India and assist the adoptees.

In general you could investigate for India from the Desk in NL, whether Wereldkinderen has complete files.

You will find out, Wereldkinderen hasn't.

Wereldkinderen doesn't have:

Birthcertificate

Petition filed in the Bombay High Court,

Annexures to the petition such as:

Relinquishment paper

Or abandonment declaration of Juvenile Welfare Board.

Here definitely the ministry of justice as well as the foreign affairs ministry which issued the visa's , have done very wrong.

This failure effectively erased the identity of most indian adult adoptees and makes searches so very difficult.

The Dutch state violated the rights of the children and their right to know their origins, systematically.

To verify my claim is very easy. Just check randomly 100 files of Wereldkinderen. – which likely they will not provide and cite privacy reasons.

The adoptees ought to be compensated financially for this. A significant lump sum.

Thank you for sharing your concerns with us. I am pleased to receive this kind of input, since it allows alternatives for rethought. As you know, we have already reconsidered the position of Fiom in our first proposal. Evaluation and reflection on the plans would in the end be done by the Ministry of Justice, and we also decide about the spending of the budget. We think that it is necessary to have an organization to coordinate all the plans, and also to give help – where needed – when it comes to setting up a plan. Your e-mail suggests that you agree with this. However, in your opinion, Fiom is not the right party to do this. I still believe that Fiom, as an independent knowledge institute, is the organization best able to take on this role in the process. In my view, the cooperation with Fiom is aimed at the facilitation of knowledge exchange whereby roots searches may be improved and initiatives in the same countries get more aligned. it has come to our notice that the Joustra Commission will not look into issues and the trafficking regarding adoptions from India.

Further we learned that your ministry plans to give all the funding to the FIOM only.

In the light of the motion passed by the dutch parliament on 4 september 2019 which also calls on the Dutch government to solve the issue of childtrafficking, and the below communication, I request you to grant ACT/ ARC funding.

We assisted so far 48 adult adoptees with re-establishing their original identities.

We get every day requests from adoptees for assistance. Often from very young adoptees, who don't necessarily even have the financial support of their adoptive parents.

Obviously they lack the financial resources.

Therefore I propose the following very practically orientated.

The Ministry of justice should fund us with 150.000 EUR for 2020.

In return we will take up cases cost free for the adoptees or adoptive families on a first come first served basis.

End of 2020 we together evaluate this project and likely would in the mid-run not more than a steady funding of 300.000 EUR per year to be able to cost free solve cases.

One of the obstacles we faced to assist adoptees appropriately was now this week removed (totally on our expenses) by the High Court of Mumbai.

In fact this obstacle had been put in the CARA Guidelines in 2010, by the Partner of Wereldkinderen to stop our work.

That at a time where we closely cooperated with Wereldkinderen.

Der Höhepunkt der Frechheit war wohl, dass von einer -eh der letzten Gruppe von Adoptiveltern aus Äthiopien -300 Euro pro Kind mitten im Adoptionsprozess nachverlangt wurden, weil die Kinder angeblich aus einem Waisenhaus im Süden nach Addis gebracht wurden.- für den Transport - Diese Eltern haben übrigens Adoptionsverträge mit Waisenhäusern in Addis! Wenn Kinder vom Land ins Waisenhaus nach Addis kommen und dann adoptiert werden, ist das ansonsten in

Äthiopien in keiner Weise üblich, dass hier Transportkosten den Adoptiveltern nachverrechnet werden!

Werden die Adoptwerber auf so etwas vorbereitet sein oder treffen hier wieder falsche, auch sehr naive, Vorstellungen auf schwierige Kinder und die nächsten Abstürze sind vorprogrammiert?

Ist das Adoptionsprogramm dort tatsächlich so sicher, dass es man es vom Schreibtisch in Wien aus betreiben kann?

Meine Freundin erzählt mir dass es auf den Philippinen unbeschreiblich grausame Sitten und Kriminalität gibt. Es sei gar nicht nötig zu adoptieren, man könne sich jederzeit ein Kind von einem Arzt, der in Amerika seine Lizenz verloren hat, kaufen, der bestätigt dann, dass man es selbst geboren hat.

Soviel zu den anderen sicheren Adoptionsländern, die family im Programm hat.

Aber das ist ja dann die Sache der Stadt Wien.

Ich denke es wird ihnen auch nur von den Behörden soviel verziehen, weil sie einerseits gute Selbstdarsteller sind, auch gute Kontakt haben, aber auch und vor allem deshalb, weil es viele Kinderwunscheltern gibt, die auch in Zukunft Vereine brauchen werden.

it is with a heavy heart that i have to inform you, that (10)(2e) succeeded this year with her suicide.
This is the girl i mentioned in below email who had attempted suicide twice in 2019.

She was desperately searching for her mother.

We definitely could have solved her search case already in 2015 / 2016 .

However DNA India ((10)(2e) then board of UAI , had advised her to do it herself.

He knew very well that it's mission impossible and that we can do it.

It was a bad advice.

I also found out that she was once client of (10)(2e) , who does Trauma Therapy, systemic family therapy under the guise of coaching.

Also 2 dutch south korean adoptees committed suicide.

The delay in providing proper assistance to adoptees has claimed too many lives already.

It is 100 percent the fault of the Ministry of justice and Wereldkinderen that Wereldkinderen does have incomplete files.

No original Birth Certificates.

No relinquishment document.

Not even the full copy of the guardianship application with annexes filed by the Wereldkinderen a representative in the name of the adoptive parents in India.

Under this link you can download the conviction of the traffickers in the Malaysian Social Service case.

Maybe it makes sense if the Joustra Commission investigates what dutch officials may have done wrong.

Personally I don't see much sense in the Joustra Commission investigating this.

All what needs to happen, is that the Minister acknowledges that this happened and request the Openbaare Ministerie to open a broader criminal investigation extending to India and into the conduct of Meiling and possible involvement of dutch officials.

As part of it the OM can request via letter rogatory assistance from the Indian criminal investigation agency CBI.

The adoptive families, the adopted now adult children, can request their cases to be investigated by the OM. The Indian criminal investigation agency CBI can then verify the documents and look into each case.

Additionally the Ministry can fund ACT / ARC and we can equally assist the families and adoptees with their searches and hopefully the reunions.

We are also in a position, to push the Indian government to set up a local DNA Database, so that even cases where the paperwork was totally concocted can be solved.

It's all not rocket science.

It's just obvious that since now almost 14 years the ministry of justice has no interest in the fact that any truth comes out.

Just a total cover up.

For the rest of India, answers on whether the adoptions were conducted in line with the existing legal framework can only be found, if one is able to trace back the Indian families.

You cannot even do it from the desk in the Netherlands.

The Wereldkinderen Partners are uncooperative. That is a big fight we fight since many years.

Though we solved some Dutch cases, and can provide you detailed case studies on request.

First and foremost ACT needs funding to be able to fight it through in India and assist the adoptees.

In general you could investigate for India from the Desk in NL, whether Wereldkinderen has complete files.

You will find out, Wereldkinderen hasn't.

Wereldkinderen doesn't have:

Birthcertificate

Petition filed in the Bombay High Court,

Annexures to the petition such as:

Relinquishment paper

Or abandonment declaration of Juvenile Welfare Board.

Here definitely the ministry of justice as well as the foreign affairs ministry which issued the visa's, have done very wrong.

This failure effectively erased the identity of most Indian adult adoptees and makes searches so very difficult.

The Dutch state violated the rights of the children and their right to know their origins, systematically.

To verify my claim is very easy. Just check randomly 100 files of Wereldkinderen. – which likely they will not provide and cite privacy reasons.

The adoptees ought to be compensated financially for this. A significant lump sum.

(investigation not only into preet mandir, but the other agencies too)

You all know that I am rather sceptical about the possibilities to change
the system for the better. And I know all too well that people simply do not
want to hear the truth of the matter.

However, I think [REDACTED] (10)(2e) has created here a golden window of opportunity.

I would suggest we jointly prepare a hyper strong document, as [REDACTED] (10)(2e) asks
for a broader discussion on Ethiopia.

Some first ideas on what the document could include:

- * The US Embassy's warning about contact with bio families
- * Should adoptions from intact families be allowed

- * should adoptions for reason of poverty be allowed
- * the fact that there are more and more chidren homes run by adoption agencies
- * competition, projects in return for children (article AFA of 2007 about competition)
- * the adoption market is moving to Afrika ((10)(2e) (10)(2e))
- * Italy, Spain, France allow contact with children before adoption is agreed (report TdH - adoption at what cost, 2008)
- * is it ethical to have children's homes and unwed motherhomes financed by adoption money
- * full adoption is not known in Africa
- * Togo, Zambia, Congo have stopped adoptions
- * Zambia - judges declared children abandoned without any social investigation
- * Looking into older adoptions, often paperwork seems not to have been correct/complete. Can this be prevented?
- * Example of India (Dutch and Danish cases - also Euradopt members involved)

We could make a paper of a few pages and add all the annexes/proof.

(10)(2e) could then propose to have a follow up meeting in The Hague - in a few months - to discuss this further. And to ask all other Euradopt members to provide any info on adoptions that have caused problems, were doubtful.

And to provide openness in their adoption cost and the adoption partners in

third countries.

Another issue: how can it be that when a Euradopt member's CAs decides a country does not hold sufficient securities to do adoptions (Cambodia, Vietnam), that other countries just continue. Should Euradopt not play a role in that discussion.

When all this gets on the table, then it will be difficult to deny the problems and some discussion will need to take place.

I think it is too early for me to step in now. They first need something to wake them up (brutally).

Looking forwards to your ideas/suggestions about this.


Frankly i m a bit surprised that first the Committee said they will not look into anything beyond the original mandate, now it is changed. But i cannot submit anything?



Yesterday was a very bad day for children's rights. I watched the whole Dutch debate online and I'm shocked. I heard you saying in Netwerk something like- that you are really upset that here rights of prospective adoptive parents prevailed over children's rights". >From my side I couldn't agree more with you on that.

I agree with you that children's rights should come first. That was the common ground for the cooperation we had for the last 17 Months: to see if children's rights were fully respected in WK's adoptions, as at the time some gross irregularities (to say the least) made headlines in relation to adoptions from India. However, during both the Indian and Ethiopian Research I felt a huge resistance.

What really needed to be done was to go into the field, find the parents and

to see why and how the children became adoptable. Were all steps

done

correctly. The underlying question then would be of course: was the

adoption necessary or were other local options available?

You now propose to replace me by another person, with less experience and

part of your organisation. And you ask if I could then be involved from a

distance.

My reply must be a clear no. Either I am free in checking the information

on

the ground (accompanied by WK staff/Ethiopian resource person - but not by

(10)(2e)) or I renounce responsibility.

In that case my interim report will be the final report and should

be presented to WK's board.

I will then do further research in Ethiopia independently from WK.

cooperation with you. But on the other hand, if she is at the payroll of

Wereldkinderen, can she still be seen as objective, don't she has the

appearances against her? At the other hand, she has the same mission as

Wereldkinderen: to get the right information about the background of the

children. How do you feel about this. We would like to ask you you to come

with advice too.

In the meantime we want - from now on - that a person who is objective and

trustable (maybe the same as the woman I mentioned above), speaks to the

biological mother when she appears at the Court. To make sure that she

really wants that her child goes for adoption. And if there's no biological mother or father, she has to go back to the source to verify the information about the child. Check and doublecheck.

We realize that the situation in Ethiopia is very difficult and risky, and we want to be very careful. We try to minimize the risks, but we also know that we don't get a 100% guarantee. But we do our best to come as close as possible to the 100%.

Maybe it's a good idea to see each other on a short term at the office to make up our minds?

According to our information: It concerns two children, both born in (10)(2e). They are proposed to Dutch couples in (10)(2e) at the age of (10)(2e). Before they were placed in BalAnand they lived in a state home for mentally handicapped women. The Court ordered that these children had to leave there, because they did not get the care a young child need. The mothers were not able to take care of the children. In 2006 the children were placed in BalAnand, by the Child Welfare Committee, via the Court. This was without any pressure of BalAnand of Wereldkinderen. Now the Court requires more investigation on the mental health of the mothers. This procedure is now pending. I'm sure that BallAnand does the best they can to find the relatives of these children. If you see what BalAnand does to stimulate domestic adoptions, there is no doubt about the intentions of BalAnand and they don't circumvent the rules.

Even though we'd love them to be around, this cannot be a permanent home for them, after all. I am writing to you at the advice of (10)(2e) (10)(2e) a Colombian) and I are dedicated to assist Colombian adoptees and their biological families to find each other. We have received a request from a Colombian biological mother who has been searching for her son for many years.

Below is the translated story of her letter to us:

Biological name of adoptee: (10)(2e) - unknown adopted name

QUOTE

There are several inconsistencies in the civil registry.

There is a notary authentication where I legalize the surrender of my baby, but I was underage and could not sign, they made me sign a document with the excuse that they had to perform a medical procedure but that did not happen, I was tricked.

Another inconsistency in the document is that the ID number appears another number that is not known whose it is and whoever wrote it was another person and not me because the handwriting and ID number do not correspond to my writing much less the signature and the seal of the notary .

Another inconsistency is that I never went to a Notary, my son was born on June 8 and the document was authenticated with a June 10 date, two days after giving birth, however, I was very delicate because I fell off a ladder and because of that, the baby was born premature and I was delicate, they took my baby when he was born.

Another inconsistency in the back of the adoption document is that at that time a typewriter was used and the margins are all aligned except for the fifth line where they write past the margin, which is not allowed to do in a legal document.

A nun came to see me at the hospital, said she had been sent by sra. (10)(2e) and she made me sign on a document marked with two X's and said that I had to sign in each X saying that it was for a procedure they would do to the baby. It can be seen that the handwriting of my signature is different from that the letter's handwriting where it continues to write the card number and from where. She told me to give the baby a name, and I named him (10)(2e), the reason being that he was so ill and delicate that may die and they needed a name to bury him.

Another inconsistency is that the document says that I was single, although I was married to my son's father, and that I gave the baby up for adoption which is not the case, I did not give my son to adoption.

I looked for my son for many years because who knew the truth was my sister who was in cahoots with the baby's father (he was 32 years old and I was 17) to give up the baby. For many years, I believed the baby had died, he had been born premature (7 months) and they told me his health was very delicate. Recently, my sister told me to go to FANA. I was never told what had happened to the baby. I had come from a small town and this is over forty years ago, where the customs and culture were very different from now.

FANA confirmed to me that the baby was alive and that he had been given for adoption to a family in Holland. That is all they could tell me.

We have touched many doors and we really know that many obscure things surrounded the adoption of my son. We have much faith and hope to find him and so that I can have peace in my heart, and have suffered very much for all the evil things they did to me.

Please help us
