Dear CWC,

I would like to present myself as staff member of the Flemish central authority on intercountry adoption.

The director, [REDACTED], and another colleague [REDACTED] and myself are planning a working visit to India in order to get more insights on Indians adoption procedures after having assessed to process with other experts such as UNICEF, Child

Identity Protection and International Social Services. There are still some unclarities and therefor we would like to meet different stakeholders involved in an adoption procedure.

We will meet CARA at the beginning of our stay and on the 24th of January we will travel to Kolkata.

It would be an honor if we could meet you as well as members of the Child Welfare Committee of Kolkata. We believe it would be particularly beneficial to gain a deeper understanding of the entire process through which a child enters the child protection system, as well as the roles and responsibilities of the various stakeholders involved. Our focus includes key areas of interest identified during our evaluations, such as the integration of adoption practices within the broader care and reception system, the application of the subsidiarity principle for children with special needs, guidance and consent of first parents, financial considerations, the practical steps in the adoption process, and ensuring the right to knowledge of origin and identity.

We would like to have met the CWC on **Friday 24/1 in afternoon or Monday 27/1, according to your preference.**

Thank you once again for your constructive cooperation. We remain at your disposal for any further questions or interpretations and look forward to hearing from you.
