My name is [REDACTED] and I'm working as an attaché for the Flemish Central Authority for Adoption (Belgium). In my work, I'll be focusing on the investigation of possible illicit practices in intercountry adoption.

Our government is willing to investigate these cases, so in the first place, I'm gathering all the information we can find. In the next step, we want to find an organization who could do the research on the individual cases of intercountry adoption.

For the past and next few months, I'll be focussing on the cases of intercountry adoption from India. Later, I will do the same for other countries of origin.

Is there a possibility that we could have a conversation about this topic? I'm very interested in your information and experiences and I'm sure it will give me more knowledge and perspective in doing my pre-investigation.
